## **RULES AND REGULATIONS 2026**

- 1. All exhibitors MUST be residents of Somerset County.
- 2. Must be 8-21 years of age as of January 1st, 2026.
- 3. Exhibitors can choose to exhibit and not sell. If they wish to sell at the fair, they MUST exhibit.
- 4. Exhibitors are permitted to show 2 steers; However, they will only be allowed to sell 1. The sale animal must be designated at check in.
- 5. Entry fee is \$10.00 per animal- CHECK ONLY- Made out to the Somerset County Fair at Tag in.
- 6. Print clearly in pen. Entries must have complete information.
- 7. Any checks for non-sufficient funds must be collected by January 15<sup>th</sup>, 2026, or the exhibitor's entry will be void. All associated fees, plus an additional \$50.00, will be due.
- 8. All steers will be properly tagged in on TAG IN DAY at GrowMark in Somerset. Identification tags, apart from PA BAI, 840 RFID tags, and the Club Calf Sale tags will be removed. Somerset County Club calf sale tags are to be used as the SCF tag. If at the fair the ear tag number on the enrollment form does not match the ear tag number on the animal and the health form, the animal MUST go home.
- 9. On weigh-in day, the minimum weight will be 1,000 pounds. Regardless of breed. There will be no drift allowed.
- 10. Exhibitors must show his/her own steer. Request for substitute of showman for show day must be made, in writing, to the fair specie superintendent prior to the show. Show day circumstances can be addressed verbally by the specie superintendent. Substitute showman must be from Somerset County and preferably someone showing market steers the same day. Substitutes will not be eligible for showmanship.
- 11. All animals MUST be fed and cared for in Somerset County. FAIRBOARD HAS THE RIGHT TO DO RANDOM CHECKS.
- 12. Be sure to use only grooming products approved for the use on meat and dairy animals when fitting animals. Unapproved products may contain ingredients that result in unacceptable residues in the meat or milk. If you are not certain that a product is residue is safe. DO NOT USE IT.
- 13. The animal must be born after January 1, 2025, to be shown at the 2026 Somerset County Fair.
- 14. \*\*IMPORTANT\*\* IF UPON SLAUGHTER, TREATMENT WITH DRUGS, BIOLOGICS, OR ANY CHEMICAL PRODUCTS IS THE CAUSE OF CONTAMINATION OF A CARCASS, THE LOSS OF THE CARCASS AND ANY OTHER DAMAGES WILL BE BORNE BY THE EXHIBITOR.
- 15. The animal must be a steer and dehorned by tag in day.
- 16. Adequate rope halters must be provided by the exhibitor and left with the steer following the sale. If the halter is not provided, the sale committee will provide one and 5.00 will be deducted from the exhibitor's sale receipt.
- 17. There will be NO argumental contact with any judges at the fair. If an exhibitor or spectator is found by the show committee to be violating this rule, security and the police will be contacted, and the individual (s) will be removed from the grounds. The judge's decisions are final.
- 18. Please check the upcoming fair book for new protest rules that will apply to all the upcoming fair livestock shows.

TAG IN RULES- STEERS MUST HAVE A HALTER ON AND BE ABLE TO BE TIED TO THE TRAILER- NO LOOSE STEERS IN TRAILERS WILL BE TAGGED.

CALVES PURCHASED AT THE CLUB CALF SALE DO NOT NEED TO BE BROUGHT TO THE TAG IN-BUT A PICTURE OF THE HEAD OF THE CALF WITH THE TAG VISIBLE IS REQUIRED TO BE BROUGHT TO TAGIN ALONG WITH THIS FORM COMPLETED AND FEES ASSOCIATED.
